Subject: Adjusted Nikola Corporation – Cash In Lieu Settlement

Adjusted Option Symbols: NKLA1/1NKLA1/2NKLA1

Adjusted Nikola Corporation options were adjusted on June 25, 2024 (See OCC Information Memo #54772). The new deliverable became 1) 3 Nikola Corporation (NKLA) Common Shares and 2) Cash in lieu of approximately 0.3333 fractional NKLA Shares. Only settlement of the cash portion of NKLA1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$7.940415 per whole NKLA share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

 $0.3333 \times 7.940415 = 2.65 \text{ per NKLA1/1NKLA1/2NKLA1 Contract}$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of June 25, 2024 through July 09, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the NKLA1 options are as follows:

New Deliverable

Per Contract: 1) 3 Nikola Corporation (NKLA) Common Shares

2) \$2.65 Cash

Strike Prices: Unchanged

CUSIP: NKLA: 654110303

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

<u>Settlement</u>

The NKLA component of NKLA1/1NKLA1/2NKLA1 exercise/assignment activity from June 25, 2024 through July 8, 2024, has settled through National Security Clearing Corporation (NSCC). The \$2.65 cash amount will be settled by OCC.

Pricing

The underlying price for NKLA1/1NKLA1/2NKLA1 will be determined as follows:

$$NKLA1 = 0.03 (NKLA) + 0.0265$$

For example, if NKLA closes at 10.49, the NKLA1/1NKLA1/2NKLA1 price would be calculated as follows:

$$NKLA1 = 0.03 (10.49) + 0.0265 = 0.34$$
