New York Community Bancorp, Inc. (NYCB) has announced a 1-for-3 reverse stock split. As a result of the reverse stock split, each NYCB Common Share will be converted into the right to receive approximately 0.333333 (New) New York Community Bancorp, Inc. Common Shares. The reverse stock split will become effective before the market open on July 12, 2024. Cash will be paid in lieu of fractional shares.

Delayed Settlement

The NYCB component of the NYCB1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the NYCB1 deliverable until the cash in lieu of fractional NYCB Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
