Subject: FMX2 Options - Expiration Pricing Consideration

FMX2 (adjusted Fomento Económico Mexicano, S.A.B. de C.V. options) will be subject to special pricing consideration in expiration processing on July 19, 2024. The pricing consideration is due to the undetermined final net cash amount included in the option deliverable of FMX2 as indicated below. These options will continue to be subject to normal exercise based on customary exercise thresholds in OCC's Ex-by-Ex processing.

MEMBERS SHOULD ADVISE THEIR CUSTOMERS TO TAKE THE FOLLOWING CONSIDERATIONS INTO ACCOUNT IN DECIDING TO EXERCISE, OR NOT TO EXERCISE, THESE OPTIONS.

FMX2

FMX2 options are adjusted Fomento Económico Mexicano, S.A.B. de C.V. options, adjusted July 17, 2024 (see OCC Information Memo #54842). The deliverable of FMX2 options is:

NEW DELIVERABLE

PER CONTRACT:

- 1) 100 Fomento Económico Mexicano, S.A.B. de C.V. (FMX) American Depositary Shares
- 2) Approximately \$42.18 Cash (approximately \$0.421806 x 100)

As of July 18, 2024, the FMX Distribution Agent has not determined the final net dividend amount.

For purposes of calculating a FMX2 price for use in expiration processing, OCC will use the following formula:

$$\text{FMX2} = \text{FMX} + 0.4218$$

For example, if FMX closes at 117.60, the FMX2 price would be:

$$\text{FMX2} = 117.60 + 0.4218 = 118.02$$

This formula includes an estimate for the value of the cash in the deliverable and not the actual final net cash dividend amount applicable in the distribution.
