**Subject:** Adjusted Tectonic Therapeutic, Inc. – Cash In Lieu Settlement  
Adjusted Option Symbol: TECX1

Adjusted Tectonic Therapeutic, Inc. (formerly AVROBIO, Inc.) options were adjusted on June 21, 2024 (See OCC Information Memo #54763). The new deliverable became 1) 8 (New) Tectonic Therapeutic, Inc. (TECX) Common Shares and 2) Cash in lieu of approximately 0.3333 fractional TECX shares. Only settlement of the cash portion of TECX1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$17.04 per whole TECX share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$17.04 = \$5.68 \text{ per TECX1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of June 21, 2024 through July 19, 2024, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the TECX1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 8 Tectonic Therapeutic, Inc. (TECX) Common Shares  
2) \$5.68 Cash

**Strike Prices:** Unchanged

**CUSIP:** TECX: 878972108

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The TECX component of TECX1 exercise/assignment activity from June 21, 2024 through July 18, 2024, has settled through National Security Clearing Corporation (NSCC). The \$5.68 cash amount will be settled by OCC.

## **Pricing**

The underlying price for TECX1 will be determined as follows:

$$\text{TECX1} = 0.08 (\text{TECX}) + 0.0568$$

For example, if TECX closes at 16.36, the TECX1 price would be calculated as follows:

$$\text{TECX1} = 0.08 (16.36) + 0.0568 = 1.37$$
