Subject: Adjusted New York Community Bancorp, Inc. – Cash In Lieu
Settlement
Adjusted Option Symbol: NYCB1

Adjusted New York Community Bancorp, Inc. options were adjusted on July 12, 2024 (See OCC Information Memo #54863). The new deliverable became 1) 33 New York Community Bancorp, Inc. (NYCB) Common Shares and 2) Cash in lieu of approximately 0.3333 fractional NYCB Shares. Only settlement of the cash portion of NYCB1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$10.17 per whole NYCB share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$10.17 = \$3.39 \text{ per NYCB1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 12, 2024 through July 23, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the NYCB1 options are as follows:

The NYCB component of NYCB1 exercise/assignment activity from July 12, 2024 through July 22, 2024, has settled through National Security Clearing Corporation (NSCC). The \$3.39 cash amount will be settled by OCC.

Pricing

The underlying price for NYCB1 will be determined as follows:

$$\text{NYCB1} = 0.33 (\text{NYCB}) + 0.0339$$

For example, if NYCB closes at 11.02, the NYCB1 price would be calculated as follows:

$$\text{NYCB1} = 0.33 (11.02) + 0.0339 = 3.67$$
