On July 16, 2024, Shareholders of U.S. Silica Holdings, Inc. (SLCA) voted concerning the proposed merger with wholly owned subsidiary of Star Holding LLC, which are both affiliates of Apollo Funds and managed by affiliates of Apollo Global Management, Inc. The merger was approved and subsequently consummated on July 31, 2024. As a result, each existing SLCA Common Share will be converted into the right to receive \$15.50 net cash per share.

Per Contract:** \$1,550.00 Cash (\$15.50 x 100)

Settlement in SLCA options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of U.S. Silica Holdings, Inc. options whose expiration dates are after 08-16-2024 will have their expiration dates advanced to 08-16-2024. Expiration dates occurring before 08-16-2024 (e.g., Flex options) will remain unchanged.

All U.S. Silica Holdings, Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 08-16-2024

Existing American-style U.S. Silica Holdings, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
