**Subject:** Macatawa Bank Corporation – Cash In Lieu Settlement  
Adjusted Option Symbol: WTFC1

Macatawa Bank Corporation options were adjusted on August 1, 2024 (See OCC Information Memo #54969). The new deliverable became 1) 13 Wintrust Financial Corporation (WTFC) Common Shares, and 2) Cash in lieu of 0.7 fractional WTFC Common Shares. Only settlement of the cash portion of WTFC1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$108.7618 per whole WTFC share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.70 \times \$108.7618 = \$76.13 \text{ per WTFC1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of August 1, 2024 through August 12, 2024, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the WTFC1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 13 Wintrust Financial Corporation (WTFC) Common Shares  
2) \$76.13 Cash

**Strike Prices:** Unchanged

**CUSIP:** WTFC: 97650W108

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The WTFC component of WTFC1 exercise/assignment activity from August 1, 2024 through August 9, 2024, has settled through National Security Clearing Corporation (NSCC). The \$76.13 cash amount will be settled by OCC.

## **Pricing**

The underlying price for WTFC1 will be determined as follows:

$$\text{WTFC1} = 0.13 (\text{WTFC}) + 0.7613$$

For example, if WTFC closes at 98.09, the WTFC1 price would be calculated as follows:

$$\text{WTFC1} = 0.13 (98.09) + 0.7613 = 13.51$$
