Effective on August 9, 2024, settlement of TIGO options exercise/assignment activity was subject to broker to broker settlement (see memo #55016). TIGO shares (CUSIP L6388F110) are now eligible for Continuous Net Settlement ("CNS") at the National Securities Clearing Corporation ("NSCC"). As a result, all exercise and assignment activity for TIGO options as of August 12, 2024 will no longer be subject to broker to broker settlement. Exercise and assignment activity from August 12, 2024 and thereafter for TIGO options will settle through NSCC.

The deliverable for TIGO options will remain the underlying 100 Millicom International Cellular S.A. Common Shares.
