Ginkgo Bioworks Holdings, Inc. (DNA) has announced a 1-for-40 reverse stock split. As a result of the reverse stock split, each DNA Class A Common Share will be converted into the right to receive 0.025 (New) Ginkgo Bioworks Holdings, Inc. Class A Common Shares. The reverse stock split will become effective before the market open on August 20, 2024. Cash will be paid in lieu of fractional shares.

The DNA component of the DNA1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the DNA1 deliverable until the cash in lieu of fractional DNA Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
