Subject: Adjusted Ginkgo Bioworks Holdings, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: DNA1

Adjusted Ginkgo Bioworks Holdings, Inc. options were adjusted on August 20, 2024 (See OCC Information Memo #55067). The new deliverable became 1) 2 Ginkgo Bioworks Holdings, Inc. (DNA) Class A Common Shares and 2) Cash in lieu of 0.5 fractional DNA Shares. Only settlement of the cash portion of DNA1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$9.36 per whole DNA share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.5 \times \$9.36 = \$4.68 \text{ per DNA1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of August 20, 2024 through August 30, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the DNA1 options are as follows:

New Deliverable

Per Contract: 1) 2 Ginkgo Bioworks Holdings, Inc. (DNA) Class A Common Shares
2) \$4.68 Cash

Strike Prices: Unchanged

CUSIP: DNA: 37611X209

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The DNA component of DNA1 exercise/assignment activity from August 20, 2024 through August 29, 2024, has settled through National Security Clearing Corporation (NSCC). The \$4.68 cash amount will be settled by OCC.

Pricing

The underlying price for DNA1 will be determined as follows:

$$\text{DNA1} = 0.02 (\text{DNA}) + 0.0468$$

For example, if DNA closes at 7.09, the DNA1 price would be calculated as follows:

$$\text{DNA1} = 0.02 (7.09) + 0.0468 = 0.19$$
