On August 16, 2024, the U.S. Bankruptcy Court for the District of New Jersey confirmed the Second Amended Joint Chapter 11 Plan of Reorganization ("Plan") for Rite Aid Corporation (RADCQ). The Plan became effective on September 3, 2024, and RADCQ shares were canceled.

Contract Adjustment

Effective September 3, 2024, existing RADCQ options are adjusted to no longer call for the delivery of RADCQ shares upon exercise.

The option symbol RADCQ will not change.

In settlement of RADCQ exercise/assignment activity, a RADCQ put exerciser (or call assignee) will receive a cash payment of the full aggregate strike price amount on the exercise settlement date. A RADCQ put assignee (or call exercise) will pay this amount on the exercise settlement date. Settlement will take place through OCC's cash settlement system on the business day after exercise.

Since RADCQ options are American-style, they are exercisable at the election of the holder. Expiration processing for RADCQ options will take place in the normal fashion, including automatic exercise thresholds.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Rite Aid Corporation options whose expiration dates are after 09-20-2024 will have their expiration dates advanced to 09-20-2024. Expiration dates occurring before 09-20-2024 (e.g., Flex options) will remain unchanged.

All Rite Aid Corporation options will utilize a \$.01 exercise threshold.

New expiration date: 09-20-2024

Existing American-style Rite Aid Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
