The Container Store Group, Inc. (TCS) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each TCS Common Share will be converted into the right to receive approximately 0.066667 (New) The Container Store Group, Inc. Common Shares. The reverse stock split will become effective before the market open on September 4, 2024. Cash will be paid in lieu of fractional shares.

**Contract Adjustment**

**Strike Divisor:** 1

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

**Pricing**

Until the cash in lieu amount is determined, the underlying price for TCS1 will be determined as follows:

$$\text{TCS1} = 0.066667 (\text{TCS})$$

## **Delayed Settlement**

The TCS component of the TCS1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the TCS1 deliverable until the cash in lieu of fractional TCS Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
