On June 7, 2024, the Principal Stockholders, which owned approximately 69.8% of the voting power of the issued and outstanding shares of PowerSchool Holdings, Inc. (PWSC), delivered written consent approving the merger agreement between PWSC and a wholly owned subsidiary of BCPE Polymath Buyer, Inc., which are both affiliates of Bain Capital Private Equity, LP. If and when the merger is consummated, each existing PWSC Class A Common Share will be converted into the right to receive \$22.80 net cash per share.

## Contract Adjustment

Date:Effective the opening of the business day after the merger is consummated.<br/>Contract adjustment is expected to occur in the second half of 2024.

Settlement in PWSC options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## Acceleration of Expirations
