On October 10, 2024, Shareholders of Chuy's Holdings, Inc. (CHUY) will vote concerning the proposed merger with Cheetah Merger Sub Inc., a wholly owned subsidiary of Darden Restaurants, Inc. If the merger is approved and consummated, each existing CHUY Common Share will be converted into the right to receive \$37.50 net cash per share.

#### **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated. Contract adjustment is expected to occur during the fourth quarter of 2024.

**New Deliverable  
Per Contract:** \$3,750.00 Cash (\$37.50 x 100)

Settlement in CHUY options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
