Subject: Adjusted Oruka Therapeutics, Inc.– Cash In Lieu Settlement Adjusted Option Symbol: ORKA1

Adjusted Oruka Therapeutics, Inc. (formerly ARCA biopharma, Inc.) options were adjusted on September 3, 2024 (See OCC Information Memo #55122). The new deliverable became 1) 8 Oruka Therapeutics, Inc. (ORKA) Common Shares and 2) Cash in lieu of approximately 0.3333 fractional ORKA Shares. Only settlement of the cash portion of ORKA1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$25.50 per whole ORKA share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

0.3333 x \$25.50 = \$8.50 per ORKA1 Contract

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of September 3, 2024 through September 13, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the ORKA1 options are as follows:

New Deliverable Per Contract:	1) 8 Oruka Therapeutics, Inc. (ORKA) Common Shares 2) \$8.50 Cash
Strike Prices:	Unchanged
CUSIP:	ORKA: 687604108
Multiplier:	100 (i.e., a premium of 1.50 yields \$150)

<u>Settlement</u>

The ORKA component of ORKA1 exercise/assignment activity from September 3, 2024 through September 12, 2024, has settled through National Security Clearing Corporation (NSCC). The \$8.50 cash amount will be settled by OCC.

Pricing

The underlying price for ORKA1 will be determined as follows:

ORKA1 = 0.08 (ORKA) + 0.0850

For example, if ORKA closes at 26.00, the ORKA1 price would be calculated as follows:

ORKA1 = 0.08 (26.00) + 0.0850 = 2.165
