Effective on September 16, 2024, settlement of GTHX options exercise/assignment activity was subject to broker to broker settlement (see OCC Information Memo #55197). GTHX shares (CUSIP 3621LQ109) are now eligible for Continuous Net Settlement (“CNS”) at the National Securities Clearing Corporation (“NSCC”). As a result, all exercise and assignment activity for GTHX options as of September 17, 2024 will no longer be subject to broker to broker settlement. Exercise and assignment activity from September 17, 2024 and thereafter for GTHX options will settle through NSCC.

The deliverable for GTHX options will remain the underlying 100 G1 Therapeutics, Inc. Common Shares.
