Subject: IWFH Options - Expiration Pricing Consideration

IWFH (iShares Virtual Work and Life Multisector ETF) options will be subject to special pricing consideration in expiration processing on September 20, 2024. The pricing consideration is due to the undetermined final cash amount included in the option deliverable of IWFH as indicated below. These options will continue to be subject to normal exercise based on customary exercise thresholds in OCC's Ex-by-Ex processing.

MEMBERS SHOULD ADVISE THEIR CUSTOMERS TO TAKE THE FOLLOWING CONSIDERATIONS INTO ACCOUNT IN DECIDING TO EXERCISE, OR NOT TO EXERCISE, THESE OPTIONS.

<u>IWFH</u>

IWFH options are iShares Virtual Work and Life Multisector ETF options, which were adjusted on August 15, 2024 (see OCC Information Memo #55050). The deliverable of IWFH options is:

NEW DELIVERABLE PER CONTRACT:

100 x the cash proceeds amount paid per IWFH share, less any applicable transactions costs, pursuant to the liquidation.

As of September 19, 2024, the IWFH Exchange Agent has not determined the final net cash amount applicable in the liquidation.

For purposes of calculating a IWFH price for use in expiration processing, OCC will use the following formula:

IWFH = 14.41

This formula only includes the first liquidating distribution and does not include any subsequent liquidating distribution amounts, if any.
