Effective on September 18, 2024, settlement of TUP options exercise/assignment activity was subject to broker to broker settlement (see OCC Information Memo #55214). TUPBQ shares (CUSIP 899896104) are now eligible for Continuous Net Settlement ("CNS") at the National Securities Clearing Corporation ("NSCC"). As a result, all exercise and assignment activity for TUP options as of September 19, 2024 will no longer be subject to broker to broker settlement. Exercise and assignment activity from September 19, 2024 and thereafter for TUP options will settle through NSCC.

The deliverable for TUP options will remain the underlying 100 Tupperware Brands Corporation Common Shares.
