Subject: OCC OvationSM Beta 2 External Testing

As previously announced in Information Memo #54710, OCC's new clearing, risk and data platform, Ovation, is anticipated to launch in mid-2025. OCC's first phase of Beta testing began in July and completed successfully on September 8, 2024 with high participation from Exchanges and Clearing Members. OCC received positive feedback from both Clearing Members and Exchanges. We will resume testing with Beta 2, scheduled to begin during the week of October 21, 2024 and continue through January 2025.

Listed below are the Beta phases. Any market participant that sends or receives files from OCC will be required to test in the various phases. Clearing Members and Exchanges should focus on preparing for the functionalities listed in Beta 2 below. A detailed list of all transmissions is included in the Appendix.

Test Plan Summary

Since Ovation is a new OCC platform, all market participants who send or receive files from OCC will be required to test even if there are no layout changes to applicable transmissions. In addition, all market participants who access the platform's user interface will be required to test all functionality they utilize in their daily operations. Please see the appendix for a list of all files and screens that will be tested in Beta 2.

Testing is designed to be progressive in nature, with functionality added in each Beta release while continuing to support previously released functionality. Testing environments will include production-like accounts and products, and inventory (positions) will be staged across limited products.

In May 2024, OCC provided market participants with customized test scripts to ensure each entity executes the necessary tests for the products they clear. Test scripts are located on myocc.com. In addition, Clearing Members and Exchanges have received customized test strategies detailing the specific requirements each will need to fulfill in this Beta phase.

For Beta 2, OCC will offer training to prepare market participants for the functions they need to perform during external testing. Training sessions for Clearing Members will be posted on MyOCC. Exchanges will be contacted directly with their training session details. OCC will work directly with the Correspondent Clearing Corporation on testing with OCC.

External Test Connectivity

All Ovation testing, including inbound and outbound connectivity testing, will occur in a separate external test environment. All Clearing Members and Exchanges will be required to establish connectivity to the external test environment prior to testing. All SFTP, MQ and select API access will be supported. To set up connectivity, complete the External Test Technical Specification Form and email it to Technical Certification Services at ext.test@theocc.com.

Please note that some Non-Clearing Organizations will not be required to establish connectivity based on their interactions with OCC. Connectivity for Non-Clearing Organizations will be defined in the test strategy for each Non-Clearing Organization.
