Subject: Adjusted BlackSky Technology Inc. – Cash In Lieu Settlement

Adjusted Option Symbol: BKSY1

Adjusted BlackSky Technology Inc. options were adjusted on September 9, 2024 (See OCC Information Memo #55144). The new deliverable became 1) 12 BlackSky Technology Inc. (BKSY) Class A Common Shares and 2) Cash in lieu of 0.5 fractional BKSY Shares. Only settlement of the cash portion of BKSY1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$5.791011 per whole BKSY share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

0.5 x \$5.791011 = \$2.90 per BKSY1 Contract

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of September 9, 2024 through September 24, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the BKSY1 options are as follows:

New Deliverable

Per Contract: 1) 12 BlackSky Technology Inc. (BKSY) Class A Common Shares

2) \$2.90 Cash

Strike Prices: Unchanged

CUSIP: BKSY: 09263B207

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

<u>Settlement</u>

The BKSY component of BKSY1 exercise/assignment activity from September 9, 2024 through September 23, 2024, has settled through National Security Clearing Corporation (NSCC). The \$2.90 cash amount will be settled by OCC.

Pricing

The underlying price for BKSY1 will be determined as follows:

$$BKSY1 = 0.12 (BKSY) + 0.0290$$

For example, if BKSY closes at 5.38, the BKSY1 price would be calculated as follows:

$$BKSY1 = 0.12 (5.38) + 0.0290 = 0.67$$
