Subject: Adjusted MultiPlan Corporation – Cash In Lieu Settlement
Adjusted Option Symbol: MPLN1

Adjusted MultiPlan Corporation options were adjusted on September 23, 2024 (See OCC Information Memo #55238). The new deliverable became 1) 2 MultiPlan Corporation (MPLN) Class A Common Shares and 2) Cash in lieu of 0.5 fractional MPLN Shares. Only settlement of the cash portion of MPLN1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$7.705165 per whole MPLN share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.5 \times \$7.705165 = \$3.85 \text{ per MPLN1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of September 23, 2024 through October 08, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the MPLN1 options are as follows:

New Deliverable

Per Contract: 1) 2 MultiPlan Corporation (MPLN) Class A Common Shares
2) \$3.85 Cash

Strike Prices: Unchanged

CUSIP: MPLN: 62548M209

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The MPLN component of MPLN1 exercise/assignment activity from September 23, 2024 through October 7, 2024, has settled through National Security Clearing Corporation (NSCC). The \$3.85 cash amount will be settled by OCC.

Pricing

The underlying price for MPLN1 will be determined as follows:

$$\text{MPLN1} = 0.02 (\text{MPLN}) + 0.0385$$

For example, if MPLN closes at 9.13, the MPLN1 price would be calculated as follows:

$$\text{MPLN1} = 0.02 (9.13) + 0.0385 = 0.22$$
