Subject: Adjusted Sify Technologies Limited – Cash In Lieu Settlement
Adjusted Option Symbol: SIFY2

Adjusted Sify Technologies Limited options were adjusted on October 4, 2024 (See OCC Information Memo #55312). The new deliverable became 1) 16 Sify Technologies Limited (SIFY) American Depositary Shares and 2) Cash in lieu of approximately 0.6667 fractional SIFY Shares. Only settlement of the cash portion of SIFY2 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$2.676348 per whole SIFY share will be used to determine the cash in lieu amount at a rate of 0.6667. Accordingly, the cash in lieu amount is:

$$0.6667 \times \$2.676348 = \$1.78 \text{ per SIFY2 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of October 4, 2024 through October 18, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the SIFY2 options are as follows:

New Deliverable

Per Contract: 1) 16 Sify Technologies Limited (SIFY) American Depositary Shares
2) \$1.78 Cash

Strike Prices: Unchanged

CUSIP: SIFY: 82655M206

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The SIFY component of SIFY2 exercise/assignment activity from October 4, 2024 through October 17, 2024, has settled through National Security Clearing Corporation (NSCC). The \$1.78 cash amount will be settled by OCC.

Pricing

The underlying price for SIFY2 will be determined as follows:

$$\text{SIFY2} = 0.16 (\text{SIFY}) + 0.0178$$

For example, if SIFY closes at 3.73, the SIFY2 price would be calculated as follows:

$$\text{SIFY2} = 0.16 (3.73) + 0.0178 = 0.61$$
