Distribution Settlement  
Adjusted Option Symbol: FMX1

Adjusted Fomento Económico Mexicano, S.A.B. de C.V. (adjusted option symbol FMX1) options were adjusted on April 16, 2024, on July 17, 2024, and on October 16, 2024 (See OCC Information Memos #54535, #54955, and #55363). The new deliverable became 1) 100 Fomento Económico Mexicano, S.A.B. de C.V. (FMX) American Depositary Shares and 2) Approximately \$119.05 Cash (\$79.48 + (approximately \$0.395686 x 100)), less fees or withholdings, if any. Only settlement of the cash component of FMX1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that the final cash distribution rate is \$0.35058 (\$0.389533 gross dividend, less \$0.038953 withholding tax) per FMX share held.

Now that the distribution ratio has been determined, OCC will require Put exercisers and Call assignees, during the period of October 16, 2024 through October 28, 2024, to deliver the appropriate cash amount.

Terms of the FMX1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 100 Fomento Económico Mexicano, S.A.B. de C.V. (FMX)  
American Depositary Shares  
2) \$114.54 Cash (\$79.48 + (\$0.35058 x 100))

**Strike Prices:** Unchanged

**CUSIPS:** FMX: 344419106

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The FMX component of FMX1 exercise/assignment activity from October 16, 2024 through October 25, 2024 has settled through National Security Clearing Corporation (NSCC). The \$114.54 cash amount will be settled by OCC.

## **Pricing**

The underlying price for FMX1 options will be determined as follows:

$$\text{FMX1} = \text{FMX} + 1.1454$$

For example, if FMX closes at 96.75, the FMX1 prices would be calculated as follows:

$$\text{FMX1} = 96.75 + 1.1454 = 97.90$$
