Glatfelter Corporation (GLT) has announced a 1-for-13 reverse stock split. As a result of the reverse stock split, each GLT Common Share will be converted into the right to receive approximately 0.076923 (New) Glatfelter Corporation Common Shares. The reverse stock split will become effective before the market open on November 4, 2024. Cash will be paid in lieu of fractional shares.

**Pricing**

Until the cash in lieu amount is determined, the underlying price for GLT1 will be determined as follows:

$$\text{GLT1} = 0.076923 (\text{GLT})$$

## **Delayed Settlement**

The GLT component of the GLT1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the GLT1 deliverable until the cash in lieu of fractional GLT Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
