Danimer Scientific, Inc. (DNMR) has announced a 1-for-40 reverse stock split. As a result of the reverse stock split, each DNMR Class A Common Share will be converted into the right to receive 0.025 (New) Danimer Scientific, Inc. Class A Common Shares. The reverse stock split will become effective before the market open on November 13, 2024. Cash will be paid in lieu of fractional shares.

## **Delayed Settlement**

The DNMR component of the DNMR2 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the DNMR2 deliverable until the cash in lieu of fractional DNMR Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
