Subject: Adjusted FuelCell Energy, Inc. – Cash In Lieu Settlement

Adjusted Option Symbol: FCEL1

Adjusted FuelCell Energy, Inc. options were adjusted on November 11, 2024 (See OCC Information Memo #55507). The new deliverable became 1) 3 FuelCell Energy, Inc. (FCEL) Common Shares and 2) Cash in lieu of approximately 0.3333 fractional FCEL Shares. Only settlement of the cash portion of FCEL1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$7.50 per whole FCEL share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

 $0.3333 \times $7.50 = $2.50 \text{ per FCEL1 Contract}$ 

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of November 11, 2024 through November 22, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the FCEL1 options are as follows:

New Deliverable

Per Contract: 1) 3 FuelCell Energy, Inc. (FCEL) Common Shares

2) \$2.50 Cash

Strike Prices: Unchanged

**CUSIP:** FCEL: 35952H700

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The FCEL component of FCEL1 exercise/assignment activity from November 11, 2024 through November 21, 2024, has settled through National Security Clearing Corporation (NSCC). The \$2.50 cash amount will be settled by OCC.

## **Pricing**

The underlying price for FCEL1 will be determined as follows:

$$FCEL1 = 0.03 (FCEL) + 0.025$$

For example, if FCEL closes at 7.92, the FCEL1 price would be calculated as follows:

$$FCEL1 = 0.03 (7.92) + 0.025 = 0.26$$
