Adjusted Livent Corporation (adjusted option symbol ALTM1) options were adjusted on January 4, 2024 (See OCC Information Memo #53988). The new deliverable became 1) 240 Arcadium Lithium plc (ALTM) Ordinary Shares and 2) \$3.63 Cash.

On December 23, 2024, Shareholders of Arcadium Lithium plc (ALTM) will vote concerning the proposed scheme of arrangement with Rio Tinto BM Subsidiary Limited, a wholly owned subsidiary of Rio Tinto Western Holdings Limited. If the scheme is approved and consummated, each existing ALTM Ordinary Share will be converted into the right to receive \$5.85 net cash per share.

### Contract Adjustment

**Date:** Effective the opening of the business day after the merger is consummated.  
Contract adjustment is expected to occur in mid-2025.

**New Deliverable  
Per Contract:** \$1,407.63 Cash ( $\$3.63 + 240 \times \$5.85$ )

Settlement in ALTM1 options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

### Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
