Adjusted 22nd Century Group, Inc. (adjusted option symbol XXII1) options were adjusted on July 5, 2023 (See OCC Information Memo #54429). The new deliverable became 1 22nd Century Group, Inc. (XXII) Common Share.

22nd Century Group, Inc. (XXII) has announced a 1-for-135 reverse stock split. As a result of the reverse stock split, each XXII Common Share will be converted into the right to receive approximately 0.007407 (New) 22nd Century Group, Inc. Common Shares. The reverse stock split will become effective before the market open on December 17, 2024. The treatment of fractional shares is unknown at this time.
