Subject: Olink Holding AB (publ) - Cash Settlement/Acceleration of Expirations

On July 9, 2024, Goldcup 33985 AB (u.c.t. Orion Acquisition AB), a direct, wholly owned subsidiary of Thermo Fisher Scientific Inc., completed its tender offer for Olink Holding AB (publ). The subsequent merger was consummated before the open on July 10, 2024. As a result, each existing OLK American Depositary Share will be converted into the right to receive \$26.00 net cash per share, less fees, if any, as set forth under the ADS deposit agreement.

Per BNY Mellon, as Depositary, the OLK American Depositary Agreement will be terminated effective December 23, 2024. OLK ADS holders will be required to exchange their OLK ADSs for \$26.60 Cash (\$26.65 less \$0.05 ADS cancellation fee) per OLK ADS, per terms set by the Arbitral Tribunal decision.

Contract Adjustment

New Deliverable

Per Contract: \$2,660.00 Cash (\$26.60 x 100)

Settlement in OLK options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Olink Holding AB (publ) options whose expiration dates are after 01-17-2025 will have their expiration dates advanced to 01-17-2025. Expiration dates occurring before 01-17-2025 (e.g., Flex options) will remain unchanged.

All Olink Holding AB (publ) options will utilize a \$.01 exercise threshold.

Existing Expiration: All months New expiration date: 01-17-2025

Existing American-style Olink Holding AB (publ) options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
