On January 30, 2025, Shareholders of Avid Bioservices, Inc. (CDMO) will vote concerning the proposed merger with a wholly owned subsidiary of Space Finco, Inc., both affiliates of GHO Capital Partners LLP and Ampersand Capital Partners. If the merger is approved and consummated, each existing CDMO Common Share will be converted into the right to receive \$12.50 net cash per share.

#### **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated. Contract adjustment is expected to occur during the first quarter of 2025.

**New Deliverable  
Per Contract:** \$1,250.00 Cash (\$12.50 x 100)

Settlement in CDMO options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
