On December 9, 2024, Packaging Finance Limited, which held approximately 76.9% of the voting power of the outstanding shares of Pactiv Evergreen Inc. (PTVE), delivered written consent approving the merger agreement between PTVE and a wholly owned subsidiary of Novolex Holdings, LLC, both affiliates of Apollo Global Management, Inc. If and when the merger is consummated, each existing PTVE Common Share will be converted into the right to receive \$18.00 net cash per share.

#### **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated.  
Contract adjustment is expected to occur in mid-2025.

**New Deliverable  
Per Contract:** \$1,800.00 Cash (\$18.00 x 100)

Settlement in PTVE options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an **acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
