Subject: Adjusted KraneShares China Internet and Covered Call Strategy ETF -
Cash In Lieu Settlement
Adjusted Option Symbol: KLIP1

Adjusted KraneShares China Internet and Covered Call Strategy ETF options were adjusted on January 2, 2025 (See OCC Information Memo #55751). The new deliverable became 1) 33 KraneShares China Internet and Covered Call Strategy ETF (KLIP) Shares and 2) Cash in lieu of approximately 0.3333 fractional KLIP Shares. Only settlement of the cash portion of KLIP1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$32.10 per whole KLIP share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$32.10 = \$10.70 \text{ per KLIP1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of January 2, 2025 through January 07, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the KLIP1 options are as follows:

New Deliverable Per Contract:	1) 33 KraneShares China Internet and Covered Call Strategy ETF (KLIP) Shares 2) \$10.70 Cash
Strike Prices:	Unchanged
CUSIP:	KLIP: 500767272
Multiplier:	100 (i.e., a premium of 1.50 yields \$150)
<u>Settlement</u>	

The KLIP component of KLIP1 exercise/assignment activity from January 2, 2025 through January 6, 2025, has settled through National Security Clearing Corporation (NSCC). The \$10.70 cash amount will be settled by OCC.

Pricing

The underlying price for KLIP1 will be determined as follows:

$$\text{KLIP1} = 0.33 (\text{KLIP}) + 0.1070$$

For example, if KLIP closes at 32.00, the KLIP1 price would be calculated as follows:

$$\text{KLIP1} = 0.33 (32.00) + 0.1070 = 10.67$$
