Subject: Adjusted Cara Therapeutics, Inc. – Cash In Lieu Settlement

Adjusted Option Symbol: CARA1

Adjusted Cara Therapeutics, Inc. options were adjusted on December 31, 2024 (See OCC Information Memo #55812). The new deliverable became 1) 8 Cara Therapeutics, Inc. (CARA) Common Shares and 2) Cash in lieu of approximately 0.3333 fractional CARA Shares. Only settlement of the cash portion of CARA1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$5.2116 per whole CARA share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

0.3333 x \$5.2116 = \$1.74 per CARA1 Contract

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of December 31, 2024 through January 16, 2025, to deliver the appropriate cash amount

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the CARA1 options are as follows:

New Deliverable

Per Contract: 1) 8 Cara Therapeutics, Inc. (CARA) Common Shares

2) \$1.74 Cash

Strike Prices: Unchanged

CUSIP: CARA: 140755208

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The CARA component of CARA1 exercise/assignment activity from December 31, 2024 through January 15, 2025, has settled through National Security Clearing Corporation (NSCC). The \$1.74 cash amount will be settled by OCC.

Pricing

The underlying price for CARA1 will be determined as follows:

$$CARA1 = 0.08 (CARA) + 0.0174$$

For example, if CARA closes at 4.46, the CARA1 price would be calculated as follows:

$$CARA1 = 0.08 (4.46) + 0.0174 = 0.37$$
