On October 21, 2024, Dell Marketing L.P., which as of that date owned approximately 97.4% of the voting power of the issued and outstanding shares of SCWX, executed and delivered written consent approving the merger agreement between SCWX and a wholly owned subsidiary of Sophos Inc. The merger was subsequently consummated before the open on February 3, 2025. As a result, each existing SCWX Class A Common Share will be converted into the right to receive \$8.50 net cash per share.

Settlement in SCWX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of SecureWorks Corporation options whose expiration dates are after 02-21-2025 will have their expiration dates advanced to 02-21-2025. Expiration dates occurring before 02-21-2025 (e.g., Flex options) will remain unchanged.

All SecureWorks Corporation options will utilize a \$.01 exercise threshold.

Option Symbol: SCWX Existing Expiration: All months New expiration date: 02-21-2025 Existing American-style SecureWorks Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
