Delayed Settlement

The CHTR component of the CHTR1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the CHTR1 deliverable until the cash in lieu of fractional CHTR shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

On February 26, 2025, Shareholders of Liberty Broadband Corporation Series A (LBRDA) will vote concerning the proposed merger with Charter Communications, Inc. (CHTR). If the merger is approved and consummated, each existing LBRDA Series A Common Share will be converted into the right to receive 0.236 CHTR Class A Common Shares. Cash will be paid in lieu of fractional CHTR shares.
