**Subject:** Adjusted Eyenovia, Inc. – Cash In Lieu Settlement  
Adjusted Option Symbol: EYEN1

Adjusted Eyenovia, Inc. options were adjusted on February 3, 2025 (See OCC Information Memo #55979). The new deliverable became 1) 1 Eyenovia, Inc. (EYEN) Common Share and 2) Cash in lieu of 0.25 fractional EYEN Shares. Only settlement of the cash portion of EYEN1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$2.768 per whole EYEN share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.25 \times \$2.768 = \$0.69 \text{ per EYEN1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of February 3, 2025 through February 10, 2025, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the EYEN1 options are as follows:

**New Deliverable**  
**Per Contract:** 1) 1 Eyenovia, Inc. (EYEN) Common Share  
2) \$0.69 Cash

**Strike Prices:** Unchanged

**CUSIP:** EYEN: 30234E203

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The EYEN component of EYEN1 exercise/assignment activity from February 3, 2025 through February 7, 2025, has settled through National Security Clearing Corporation (NSCC). The \$0.69 cash amount will be settled by OCC.

## **Pricing**

The underlying price for EYEN1 will be determined as follows:

$$\text{EYEN1} = 0.01 (\text{EYEN}) + 0.0069$$

For example, if EYEN closes at 1.80, the EYEN1 price would be calculated as follows:

$$\text{EYEN1} = 0.01 (1.80) + 0.0069 = 0.02$$
