Subject: Adjusted Bionano Genomics, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: BNGO1

Adjusted Bionano Genomics, Inc. options were adjusted on January 27, 2025 (See OCC Information Memo #55943). The new deliverable became 1) 1 Bionano Genomics, Inc. (BNGO) Common Share and 2) Cash in lieu of approximately 0.6667 fractional BNGO Shares. Only settlement of the cash portion of BNGO1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$9.75 per whole BNGO share will be used to determine the cash in lieu amount at a rate of 0.6667. Accordingly, the cash in lieu amount is:

$$0.6667 \times \$9.75 = \$6.50 \text{ per BNGO1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of January 27, 2025 through February 10, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the BNGO1 options are as follows:

New Deliverable
Per Contract: 1) 1 Bionano Genomics, Inc. (BNGO) Common Share
2) \$6.50 Cash

Strike Prices: Unchanged

CUSIP: BNGO: 09075F404

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The BNGO component of BNGO1 exercise/assignment activity from January 27, 2025 through February 7, 2025, has settled through National Security Clearing Corporation (NSCC). The \$6.50 cash amount will be settled by OCC.

Pricing

The underlying price for BNGO1 will be determined as follows:

$$\text{BNGO1} = 0.01 (\text{BNGO}) + 0.0650$$

For example, if BNGO closes at 5.84, the BNGO1 price would be calculated as follows:

$$\text{BNGO1} = 0.01 (5.84) + 0.0650 = 0.12$$
