Subject: Adjusted 5E Advanced Materials, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: FEAM1

Adjusted 5E Advanced Materials, Inc. options were adjusted on February 18, 2025 (See OCC Information Memo #56055). The new deliverable became 1) 4 5E Advanced Materials, Inc. (FEAM) Common Shares and 2) Cash in lieu of approximately 0.3478 fractional FEAM Shares. Only settlement of the cash portion of FEAM1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$6.21 per whole FEAM share will be used to determine the cash in lieu amount at a rate of 0.3478. Accordingly, the cash in lieu amount is:

$$0.3478 \times \$6.21 = \$2.16 \text{ per FEAM1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of February 18, 2025 through February 20, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the FEAM1 options are as follows:

New Deliverable

Per Contract: 1) 4 5E Advanced Materials, Inc. (FEAM) Common Shares
2) \$2.16 Cash

Strike Prices: Unchanged

CUSIP: FEAM: 33830Q208

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The FEAM component of FEAM1 exercise/assignment activity from February 18, 2025 through February 19, 2025, has settled through National Security Clearing Corporation (NSCC). The \$2.16 cash amount will be settled by OCC.

Pricing

The underlying price for FEAM1 will be determined as follows:

$$\text{FEAM1} = 0.04 (\text{FEAM}) + 0.0216$$

For example, if FEAM closes at 4.44, the FEAM1 price would be calculated as follows:

$$\text{FEAM1} = 0.04 (4.44) + 0.0216 = 0.20$$
