## Subject: Adjusted Amplify Alternative Harvest ETF – Cash In Lieu Settlement Adjusted Option Symbol: MJ1

Adjusted Amplify Alternative Harvest ETF options were adjusted on February 21, 2025 (See OCC Information Memo #56091). The new deliverable became 1) 8 Amplify Alternative Harvest ETF (MJ) Shares and 2) Cash in lieu of approximately 0.3333 fractional MJ Shares. Only settlement of the cash portion of MJ1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$25.2105 per whole MJ share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

0.3333 x \$25.2105 = \$8.40 per MJ1 Contract

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of February 21, 2025 through February 26, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the MJ1 options are as follows:

New Deliverable Per Contract:	1) 8 Amplify Alternative Harvest ETF (MJ) Shares 2) \$8.40 Cash
Strike Prices:	Unchanged
CUSIP:	MJ: 032108474
Multiplier:	100 (i.e., a premium of 1.50 yields \$150)

## <u>Settlement</u>

The MJ component of MJ1 exercise/assignment activity from February 21, 2025 through February 25, 2025, has settled through National Security Clearing Corporation (NSCC). The \$8.40 cash amount will be settled by OCC.

## **Pricing**

The underlying price for MJ1 will be determined as follows:

MJ1 = 0.08 (MJ) + 0.0840

For example, if MJ closes at 23.02, the MJ1 price would be calculated as follows:

MJ1 = 0.08 (23.02) + 0.0840 = 1.93
