Subject: Adjusted BioXcel Therapeutics, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: BTAI1

Adjusted BioXcel Therapeutics, Inc. options were adjusted on February 10, 2025 (See OCC Information Memo #56017). The new deliverable became 1) 6 BioXcel Therapeutics, Inc. (BTAI) Common Shares and 2) Cash in lieu of 0.25 fractional BTAI Shares. Only settlement of the cash portion of BTAI1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$2.64 per whole BTAI share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.25 \times \$2.64 = \$0.66 \text{ per BTAI1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of February 10, 2025 through February 28, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the BTAI1 options are as follows:

New Deliverable

Per Contract: 1) 6 BioXcel Therapeutics, Inc. (BTAI) Common Shares
2) \$0.66 Cash

Strike Prices: Unchanged

CUSIP: BTAI: 09075P204

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The BTAI component of BTAI1 exercise/assignment activity from February 10, 2025 through February 27, 2025, has settled through National Security Clearing Corporation (NSCC). The \$0.66 cash amount will be settled by OCC.

Pricing

The underlying price for BTAI1 will be determined as follows:

$$\text{BTAI1} = 0.06 (\text{BTAI}) + 0.0066$$

For example, if BTAI closes at 1.73, the BTAI1 price would be calculated as follows:

$$\text{BTAI1} = 0.06 (1.73) + 0.0066 = 0.10$$
