On February 27, 2025, Shareholders of Emcore Corporation (EMKR) voted concerning the proposed merger with Velocity Merger Sub, Inc., a wholly owned subsidiary of Velocity One Holdings, LP. The merger was approved and subsequently consummated on February 28, 2025. As a result, each existing EMKR Common Share will be converted into the right to receive \$3.10 net cash per share.

Per Contract:** \$310.00 Cash (\$3.10 x 100)

Settlement in EMKR options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Emcore Corporation options whose expiration dates are after 03-21-2025 will have their expiration dates advanced to 03-21-2025. Expiration dates occurring before 03-21-2025 (e.g., Flex options) will remain unchanged.

All Emcore Corporation options will utilize a \$.01 exercise threshold.

New expiration date: 03-21-2025

Existing American-style Emcore Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
