On January 31, 2025, Investment Managers Series Trust II announced that it will terminate and subsequently liquidate the Tradr 1.75X Long NVDA Weekly ETF (NVDW). The last day of trading on The NASDAQ Stock Market was February 21, 2025. **Proceeds of the liquidation were distributed to shareholders in the amount of \$29.0729 per NVDW share on March 4, 2025.**

Contract Adjustment

The option symbol NVDW will not change.

New Deliverable

Per Contract: \$2,907.29 Cash (\$29.0729 x 100)

NVDW options, which were subject to delayed settlement from February 24, 2025 through March 3, 2025, are no longer subject to delayed settlement, effective March 4, 2025.

Settlement in NVDW options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Tradr 1.75X Long NVDA Weekly ETF options whose expiration dates are after 03-21-2025 will have their expiration dates advanced to 03-21-2025. Expiration dates occurring before 03-21-2025 (e.g., Flex options) will remain unchanged.

All Tradr 1.75X Long NVDA Weekly ETF options will utilize a \$.01 exercise threshold.

Existing Expiration: All months New expiration date: 03-21-2025

Existing American-style Tradr 1.75X Long NVDA Weekly ETF options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
