## Subject: Tradr 2X Long SOXX Weekly ETF - Liquidation/Cash Settlement/Acceleration of Expirations Option Symbol: SOXW Date: 03/04/2025

On January 27, 2025, Investment Managers Series Trust II announced that it will terminate and subsequently liquidate the Tradr 2X Long SOXX Weekly ETF (SOXW). The last day of trading on The NASDAQ Stock Market was February 21, 2025. **Proceeds of the liquidation were distributed to shareholders in the amount of \$21.4339 per SOXW share on March 4, 2025.** 

## Contract Adjustment

The option symbol SOXW will not change.

New DeliverablePer Contract:\$2,143.99 Cash (\$21.4339 x 100)

SOXW options, which were subject to delayed settlement from February 24, 2025 through March 3, 2025, are no longer subject to delayed settlement, effective March 4, 2025.

Settlement in SOXW options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Tradr 2X Long SOXX Weekly ETF options whose expiration dates are after 03-21-2025 will have their expiration dates advanced to 03-21-2025. Expiration dates occurring before 03-21-2025 (e.g., Flex options) will remain unchanged.

All Tradr 2X Long SOXX Weekly ETF options will utilize a \$.01 exercise threshold.

Option Symbol: SOXW Existing Expiration: All months New expiration date: 03-21-2025 Existing American-style Tradr 2X Long SOXX Weekly ETF options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
