Abits Group Inc (ABTS) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each ABTS Ordinary Share will be converted into the right to receive approximately 0.066667 (New) Abits Group Inc Ordinary Shares. The reverse stock split will become effective before the market open on March 10, 2025. Cash will be paid in lieu of fractional shares.

ABTS1 = 0.066667 (ABTS)

Delayed Settlement

The ABTS component of the ABTS1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the ABTS1 deliverable until the cash in lieu of fractional ABTS Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
