Pegasystems Inc. (PEGA) has announced an anticipated 2 for 1 stock split, subject to Shareholder Approval on June 20, 2025. The Ex-distribution Date is anticipated to be June 23, 2025. The Payable Date is anticipated to be June 20, 2025. The Record Date is anticipated to be June 10, 2025.
