## Subject: CrossFirst Bankshares, Inc. – Cash In Lieu Settlement Adjusted Option Symbol: BUSE1

CrossFirst Bankshares, Inc. options were adjusted on March 3, 2025 (See OCC Information Memo #56131). The new deliverable became 1) 66 First Busey Corporation (BUSE) Common Shares and 2) Cash in lieu of 0.75 fractional BUSE shares. Only settlement of the cash portion of BUSE1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$23.90 per whole BUSE share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

0.75 x \$23.90 = \$17.93 per BUSE1 Contract

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of March 3, 2025 through March 12, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the BUSE1 options are as follows:

New Deliverable Per Contract:	1) 66 First Busey Corporation (BUSE) Common Shares 2) \$17.93 Cash
Strike Prices:	Unchanged
CUSIP:	BUSE: 319383204
Multiplier:	100 (i.e., a premium of 1.50 yields \$150)

## <u>Settlement</u>

The BUSE component of BUSE1 exercise/assignment activity from March 3, 2025 through March 11, 2025, has settled through National Security Clearing Corporation (NSCC). The \$17.93 cash amount will be settled by OCC.

## **Pricing**

The underlying price for BUSE1 will be determined as follows:

BUSE1 = 0.66 (BUSE) + 0.1793

For example, if BUSE closes at 21.26, the BUSE1 price would be calculated as follows:

BUSE1 = 0.66 (21.26) + 0.1793 = 14.21
