Adjusted Workhorse Group, Inc. (adjusted option symbol WKHS1) options were adjusted on June 17, 2024 (See OCC Information Memo #54712). The new deliverable became 5 Workhorse Group, Inc. (WKHS) Common Shares.

Workhorse Group, Inc. (WKHS) has announced a 1-for-12.5 reverse stock split. As a result of the reverse stock split, each WKHS Common Share will be converted into the right to receive 0.08 (New) Workhorse Group, Inc. Common Shares. The reverse stock split will become effective before the market open on March 17, 2025. Fractional shares will be rounded up to the nearest whole share.
