Tempest Therapeutics, Inc. (TPST) has announced a 1-for-13 reverse stock split. As a result of the reverse stock split, each TPST Common Share will be converted into the right to receive approximately 0.076923 (New) Tempest Therapeutics, Inc. Common Shares. The reverse stock split will become effective before the market open on April 9, 2025. Cash will be paid in lieu of fractional shares.

Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
