Subject: Territorial Bancorp Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: HOPE1

Territorial Bancorp Inc. options were adjusted on April 2, 2025 (See OCC Information Memo #56298). The new deliverable became 1) 80 Hope Bancorp, Inc. (HOPE) Common Shares and 2) Cash in lieu of 0.48 fractional HOPE Common Shares. Only settlement of the cash component of HOPE1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$10.51 per whole HOPE share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.48 \times \$10.51 = \$5.04 \text{ per HOPE1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of April 2, 2025 through April 09, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the HOPE1 options are as follows:

New Deliverable
Per Contract: 1) 80 Hope Bancorp, Inc. (HOPE) Common Shares
2) \$5.04 Cash

Strike Prices: Unchanged

CUSIP: HOPE: 43940T109

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The HOPE component of HOPE1 exercise/assignment activity from April 2, 2025 through April 8, 2025, has settled through National Security Clearing Corporation (NSCC). The \$5.04 cash amount will be settled by OCC.

Pricing

The underlying price for HOPE1 will be determined as follows:

$$\text{HOPE1} = 0.80 (\text{HOPE}) + 0.0504$$

For example, if HOPE closes at 9.14, the HOPE1 price would be calculated as follows:

$$\text{HOPE1} = 0.80 (9.14) + 0.0504 = 7.36$$
