Pricing

Until the cash in lieu amount is determined, the underlying price for ALMS1 will be determined as follows:

$$\text{ALMS1} = 0.4274 (\text{ALMS})$$

Delayed Settlement

The ALMS component of the ALMS1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the ALMS1 deliverable until the cash in lieu of fractional ALMS shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

On May 13, 2025, Shareholders of Acelyrin, Inc. (SLRN) will vote concerning the proposed merger with Alumis Inc. (ALMS). If the merger is approved and consummated, each existing SLRN Common Share will be converted into the right to receive 0.4274 ALMS Common Shares. Cash will be paid in lieu of fractional ALMS shares.
